January 8, 2020 Program: “Virginia Mineral Project” by Thomas Hale

Thomas Hale, founder of the Virginia Mineral Project, will discuss his ongoing work to develop a new mineral publication on Virginia Minerals after 30 years. He will be discussing how the MSDC and the broader mineral community can be involved in the project and what new opportunities will be coming to Virginia over the course of 2020. Thomas will showcase some of his mineral specimens and trips from across Virginia over the last few years.

Thomas went to school at Virginia Tech University and worked closely with the Geoscience Department and the Museum developing displays on Virginia Mineral History. For several years, Thomas ran The Geology Man Facebook page which connected geology outreach to thousands of people across the world and state. He also helped develop the Virginia Rockhounding group on Facebook that has grown to nearly 600 members in the last four years with a very active community base that posts daily.

Thomas’s new project is a collaborative effort to preserve and outreach Virginia’s incredible mineral history and geology. The project, known as the Virginia Mineral Project (VMP), seeks to collect and preserve stories and then share these stories, by utilizing advancements in technology to bring to life Virginia minerals and their history in ways that have never been done before, utilizing high quality images, online interactive educational facts, and stories about the discovery of classical specimens.

Please join us in taking Thomas to dinner on January 8th at 6:00 pm at the Elephant and Castle at 1201 Pennsylvania Avenue, NW. If you cannot make it to dinner, please go directly to the lobby of the Natural History museum (Constitution Avenue entrance) at 7:30 pm. We will head upstairs to the Cathy Kerby Room at 7:45 pm for Thomas’s presentation.

MSDC's December 2019 Business Meeting Report

President Dave Hennessey alerted MSDC members that because the club's December meeting was going to be our annual holiday party, the December business meeting was being deferred to our next monthly meeting scheduled for January 8th. By way of email, however, club treasurer John Weidner provided an important update on the club's checking account activity and also advised that now is the time for members to submit their annual dues of \$20 for an individual or for \$25 for a family membership.

Dues can be given to John at a monthly meeting by way of a check made out to "Mineralogical Society of DC" or can be mailed to John at 7099 Game Lord Dr., Springfield, VA 22153-1312.

Similarly, the election of MSDC's officers for 2020, which normally would have taken place at the December meeting, will happen at our January 8th club meeting. Traditionally, the Board of Directors (BOD) drafts a slate of members who have said they are willing to serve as the club's officers and the BOD proposes that list for members' consideration and for a vote at the January meeting. Additionally, any club member's name can be proposed to serve on the Board, so long as the person named has agreed to serve, the position is specified, and a reason is given for why the person's name is proposed. The reason can be very short, including, for example, that they want to serve and are willing to do so. Such additional names should be sent to the MSDC secretary, Thompson01@starpower.net, prior to the January meeting so all members can receive advance notice of the offer to serve.

At the BOD meeting in August, all current officers expressed a willingness to have their names advanced for election for the coming year. Of the three Directors, one rotates off yearly and so Ken is scheduled to become a free agent as of January 2020. In addition, Amanda gave the BOD notice that she is retiring as an MSDC Director a year early. So in effect, two Director positions need to be filled. Leslie Nanney said she would be willing to stand for election as a Director. Also, Ken said he was willing to fill in behind Amanda. Also at the August BOD meeting, there was a brief discussion about the importance of MSDC welcoming and seeking new people as club members and as BOD officers although no action was taken at the August meeting.

The BOD's list of proposed officers for 2020 include the following: President, David Hennessey; Vice-President for Programs, Yury Kalish; Treasurer, John Weidner; Secretary, Andy Thompson; Directors: Dan Teich, Ken Reynolds, and Leslie Nanney.

AFMS Code of Ethics



- I will respect both private and public property and will do no collecting on privately owned land without the owner's permission.
- I will keep informed on all laws, regulations of rules governing collecting on public lands and will observe them.
- I will to the best of my ability, ascertain the boundary lines of property on which I plan to collect.
- I will use no firearms or blasting material in collecting areas.
- I will cause no willful damage to property of any kind – fences, signs, and buildings.
- I will leave all gates as found.
- I will build fires in designated or safe places only and will be certain they are completely extinguished before leaving the area.
- I will discard no burning material – matches, cigarettes, etc.
- I will fill all excavation holes which may be dangerous to livestock. [Editor's Note/Observation: I would also include wildlife as well as livestock.]
- I will not contaminate wells, creeks or other water supply.
- I will cause no willful damage to collecting material and will take home only what I can reasonably use.
- I will practice conservation and undertake to utilize fully and well the materials I have collected and will recycle my surplus for the pleasure and benefit of others.
- I will support the rockhound project H.E.L.P. (Help Eliminate Litter Please) and will leave all collecting areas devoid of litter, regardless of how found.
- I will cooperate with field trip leaders and the se in designated authority in all collecting areas.
- I will report to my club or Federation officers, Bureau of Land management or other authorities, any deposit of petrified wood or other materials on public lands which should be protected for the enjoyment of future generations for public educational and scientific purposes.
- I will appreciate and protect our heritage of natural resources.
- I will observe the "Golden Rule", will use "Good Outdoor Manners" and will at all times conduct myself in a manner which will add to the stature and Public "image" of rockhounds everywhere.
